

Membership 2018 / 2019

Momentum Membership is open to any group or organisation that works with young people aged 11 and over. Groups and organisations who meet our minimum requirements are eligible for Full Membership (see section B). If your group doesn't yet meet these standards, you will become a Provisional Member and you will be supported to achieve the minimum standard.

Benefits of Momentum Membership include:

- Discounts on Momentum training (including "Working Together" training) and some partner training
- Discounts on DBS applications (including online applications)
- Joint membership with Voluntary Norfolk and some membership benefits from Community Action Norfolk
- Free or reduced membership of Safer (for groups with an income under £100k)

- Free advertising for your events, jobs and volunteering opportunities through the Momentum website, and social media channels
- Opportunity and support to achieve "Ambition Quality" (a nationally recognised quality mark)

SECTION C: MEMBERSHIP EXPECTATIONS

We want to ensure that our members are operating safely and providing a high-quality service to children and young people, which is why we have a minimum standard we expect our members to achieve.

In order to become a Full Member of Momentum, your group will need to meet some minimum standards to demonstrate both safety and legal compliance. We expect that all our members will hold or be working towards a relevant nationally-recognised quality mark, such as Ambition Quality (Norfolk County Council recognises this quality mark). If you have all the other minimum standards in place you will then have sufficient evidence to achieve Ambition Quality First Steps and we can support you to complete this.

For those that don't meet the minimum standards you will be registered as a Provisional Member and we will support you to achieve them. You can apply for a Start-Up / Capacity Grant of up to £500 to cover the cost of training, insurance, DBS checks or other costs relating to meeting these standards. **You can only be a Provisional Member for a maximum of two years.**
